DISCUSSION AND INFORMATION

Superintendent Eric Smola informed the board that Evergreen staff members are able to receive the COVID vaccine at the Fulton County Fairgrounds on Saturday February 27th between 12:00 noon and 2:00 pm. Staff will be divided into groups per 30-minute window to allow for a timely inoculation process. All necessary information has been provided to employees to insure they can make a well-informed decision about receiving the vaccine. Staff must complete a screening form and bring identification to the site. Insurance will not be charged for the vaccine.

Mr. Smola also thanked Kim Cupp, Health Commissioner, and the Fulton County Health Department for making this possible for our staff.

ADMINISTRATIVE REPORTS

Athletic Director, Derrick Stoup reported on the following items:

Evergreen Athletic Boosters

- Meetings have returned to campus, taking place in the Media Center of the High School on the 2nd Wednesday of each month. Some meetings will happen off-campus in hopes to benefit a local small business.
- Want to thank the Evergreen Athletic Boosters for their support of Evergreen Athletics and the continued support of our student-athletes through various donations and sponsorships throughout this challenging year.

Athletic Department Finances

- To date (2/9/21) Athletics have generated \$54,290.47 in athletic admission revenue with a 15% restriction. Which is within 71% of the previous year's (\$76,658.40) admission total. Several basketball games and track invites will still be taking place, which will bring us closer to closing the gap.
- In total, Athletics have generated revenue of \$108,401.92 to date, which is within 77% of the total revenue generated from the year prior (2019-2020)
- For the foreseeable future, the Athletic Department has taken the position to only approve purchases that are deemed absolutely necessary to the operation of athletics at Evergreen Local Schools. Knowing some items that have been denied will potentially need to be purchased in the future.
- Revenue generated this year has been slightly better than expected, operating above 70%, yet still incurring around 95% of expenses. Athletics will still potentially need assistance with future costs associated with operation.

Uniform Rotation

- As the 7th-12th grade Athletic Director, I am working to create an equitable uniform rotation and create consistency
- Excited to be working with our Treasurer (Brian Carrol) on what that will look like
- Evergreen to my knowledge has not had a structured uniform rotation in the past

Wall of Fame

We are still working on a plan for the Wall of Fame, and in discussion in regard to how we can best honor more student-athletes.

League Discussion

Several dominoes have begun to fall with several schools beginning to shift from one league to another.

- Elmwood exiting the Northern Buckeye Conference (NBC), to the Blanchard Valley Conference (BVC) to replace the void left by Leipsic heading to the Northwest Conference (NWC). This leaves a void in the NBC that they will be looking to fill, creating more uncertainty
- Movement in other leagues has the potential to affect membership within the NWOAL. Evergreen Athletics' goal has been and will remain to put our student-athletes in the best position possible if any shifts were to happen.

Superintendent Eric Smola reported on the following items:

Calamity Days:

Today was the 5th calamity day for the district because of road conditions. In addition, we have had two delayed starts for the year. We began the 2020-2021 school year with 129 hours above the state requirement for instructional time. With the time and days already missed, we have used 35.25 hours of instruction. We have a remaining balance of 93.75 hours above state requirements. That equals 15 school days for the remainder of the school year.

District In-Service:

On Friday, February 12th we held a district in-service day. The morning session was building focused with the elementary exploring behavior strategies, the middle school looked at instructional strategies for differentiation, and the high school implementation of the traditional schedule.

The afternoon sessions tied to the district strategic plan, The Viking Compass and addressed Goal II, Culture.
